5:30 P.M. – Time set for a public hearing to review a request for a 500 gallon above ground fuel tank to be located at City Plaza on Hwy 2 W

Devils Lake Planning Commission recommendation to approve a conditional use permit to allow a 500 gallon above ground fuel tank to be located on the west side of City Plaza on Highway 2 W which is zoned as highway commercial

5:30 P.M. – Time set for a public hearing to review a request for a conditional use permit to allow a laundromat at 317 4th St NE which is zoned as central area commercial
