Per the Ordinance upon renewal of this license I am providing a statement certifying gross retail sales and alcohol sales from the previous calendar year. I understand that the gross sales of alcoholic beverages may not be greater than 30% of the total gross sales of all other items sold at retail and alcoholic beverages. The Board of City Commissioners may, in its discretion, require certification of any statement by a certified public accountant, retained by the licensee.
